



### MEMORANDUM OF UNDERSTANDING

This memorandum of understanding (hereinafter referred to as MOU) is made and entered into by and between the INDIAN RED CROSS SOCIETY PFUTSERO BRANCH, and the PFUTSERO GOVERNMENT COLLEGE, PFUTSERO

Whereas. The Pfutsero Government College, Pfutsero is an educational institution established in 1982 and subsequently recognised as a Government College in the year 2009 under the Department of Higher Education, Government of Nagaland. The institute (herein after referred to as Pfutsero Government College) is a premier secular college under Phek District catering to undergraduate course in Arts under Nagaland University. Whereas, Pfutsero Government College is headed by Principal Dr. Moanochet Longchar and 34 teaching faculty of Assistant Professors, shall be assisted by the Indian Red Cross, Pfutsero Sub-Division, in training the students with disaster response, disaster preparedness, health care in the community, in promoting humanitarian principles and values and to conduct activities promoting the participation of students in the Indian Red Cross Society Movement.

The Indian Red Cross Society Pfutsero, established in 2015, though in its nascent stage is striving its best to fulfil its purpose of the society. The IRCS is a humanitarian organisation and aims to assist venerable people in times of disasters, distress and community service.

The objectives of this MoU are to express the willingness of both parties to engage in an effort to promote cooperation and to assist each other to accomplish the goals by undertaking the following activities:

- 1. Students training relating to disaster response and disaster preparedness.
- 2. To promote humanitarian services such as blood donations, response to distress cause, providing reliefs.
- 3. To facilitate activities concerning humanitarian principles and values.

This MoU intent only to assist the parties in determining and performing their obligations under this MoU. The parties to this MoU Intent and expressly agree that only parties signatory to this MoU shall

have any legal or equitable right to seek to enforce this MoU, to seek any remedy arising out of a party's performance or failure to perform any term or condition of this MoU, or to bring an action for the breach of this MoU

This agreement can be abrogated as and when required.

Settlement of dispute: Any dispute or differences or question arising at anytime between the parties in relation to the agreement shall be referred to and settled amicably between the parties.

In witness whereof, the parties to this MoU through their duly authorized representatives have excuted this MoU on the days and dates set out below, and certify that they have read, understood and agreed to the terms and conditions of this MoU as set forth herein.
